## MEMBERSHIP DETAILS:

### *Annual Dues*

Junior membership	\$ 8.00
Individual membership	\$ 12.00
Partnership membership	\$ 15.00
Family membership	\$ 15.00
Supporting membership	\$ 40.00

Any individual, partnership, family or business type, may become members upon payment of dues. All members will receive our Annual Show Catalog via USPS. All members may rent sale cages at a discounted rate. All members may submit a conservative add for a designated page on our website.

### **Junior membership**

Is limited to persons less than 18 years of age. Junior members may not hold an office, unless approved by Directors. Are not eligible to vote.

### **Individual Membership**

Is granted to any single person. Each paid Individual membership is permitted to vote on club business.

### **Partnership or Family membership**

Consists of no more than (3) three parties. Family/partner membership is restricted to one member and spouse/significant other and children in the household 18 years old and younger. *All* memberships are valid until December 31<sup>st</sup> of the calendar year. Annual membership may be paid for or renewed 3 months in advance..

Partner/Family memberships receive only one vote, regardless of the number of family members or partners. Junior members are not permitted to vote.

### **Supporting Membership**

Any business, agency, organization, corporation, or similar entity may become a supporting member upon payment of dues. Supporting memberships are for businesses, agencies, organizations or corporations interested in donating funds in addition to dues, or donation equipment or perishable items to the NCPA in exchange for advertisements in catalog and on our website, one vendor table at show, product placement or other means to be determined by an ad hoc committee when deemed necessary. Supporting memberships are permitted one vote regardless of the size of the business, corp, agency, etc.

### **Honorary Membership**

Membership is granted for exceptional circumstances to be determined by the Board of Directors and voted on by the attendees at the meetings. These members must be a member in good standing at the time of Honorary members will be exempt from annual dues. This membership would be limited to no more than 3 and would be entitled to all membership privileges excluding holding an Office. Honorary members are permitted to vote on club business.

### **Termination of membership**

Members may resign at any time. Memberships may only be terminated for the reasons listed below:

By lapsing. A membership is lapsed and automatically terminated if such member's dues remain unpaid 30 days after the first day of the year; however, the Board may grant an additional 30 days of grace to such delinquent members in meritorious cases.

By expulsion. A membership may be terminated by expulsion upon unanimous vote of all club officers, the officers shall have the power to summarily suspend, or expel and terminate the membership of, any member for any conduct in direct violation of the bylaws.

By suspension. Any member who is suspended from either the American Poultry Association or the American Bantam Association will be suspended from this club for like time.
